1) Electoral Division activities

Main Activities and the impact during the past year:

It has been a privilege to continue to serve the residents of my Division over the last 12 months. I am fortunate that the Division falls within two Parish Council in Narborough and Whetstone. Having been a Parish Councillor in Narborough for the last 31 years I am very well known in that area and am frequently contacted by residents either at home or when out and about in the Parish. In respect of Whetstone where my Division covers half of the Parish I attend parish meetings on a regular basis and liaise with the Clerk and Deputy Clerk about all County matters relating to the area working with my fellow County Councillor who covers the rest of Whetstone.

Over the past year I have dealt with numerous queries from residents 90% of which I have been able to respond to without reference to County officers using the knowledge gained since I became a County Councillor and also drawing on my long experience as both a Parish councillor and a District Councillor where my ward covers over half of the Division and where I am currently the Leader of the Council. Most of the issues raised by residents relate to traffic and highways issues, the public waste disposal site at Whetstone , school places and on rare occasions highly confidential issues relating children's services. In the last of these topics I am indebted to the Portfolio holder Ivan Ould who together with officers has been able to provide the necessary support and assistance I have required in those very few instances.

I regularly attend events throughout the Division run by numerous bodies examples being the Narborough village show, A Place to Grow open day, Christmas carol concerts, Community Library events etc where I am pleased to say residents will approach me to discuss matters of interest or concern. Such interaction keeps me fully up to date with what is happening in the Division and wider area.

- The key issue facing both villages during the past 12 months have been the traffic and parking restrictions which are being proposed especially around schools and also with the provision of residents parking. This is a key body of work I am closely involved with which will continue well into the coming year. I have been working with local residents where displacement parking could take place and where there are already parking issues. This has also meant working with the local police inspector with whom I enjoy a good relationship.
- I regularly issue written material to residents and also canvass on a regular basis.
- I believe I maintain an appropriate profile within the Division, residents have my home telephone number, e-mail address and my home address. I respond to all enquiries as soon as possible providing a hiding note if I need to seek additional information.

Engagement with the Council, other statutory bodies and public utility companies (Water, Gas etc) about services in the area

I will engage with all bodies as required and always seek greater understanding a recent example being when I queried the Police budget at a Scrutiny Commission meeting. I was contacted by the Police and Crime Commissioner for a meeting so he could talk me through his budget and I believe such meetings have led to the release of reserves to support additional police numbers.

Priorities for the immediate future are:

My first priority is to continue to support my residents. The second priority is to work within the County Council to assist the wider Group in shaping policy going forward to provide an ever better service where possible. I would not be surprised if highway and traffic issues will continue to dominate going forward.

2) Council Activities

Committees you serve on at County Hall

I am Chairman of the Adults and Communities Scrutiny Panel where we doing valuable work on issues such as the physical provision of Care accommodation, New working models to increase front line staff time in adult social care, proposals for a new heritage collections hub and many other important issues. I am Deputy Chairman of Corporate Governance which plays a crucial role in ensuring the well running of the council and reducing the risks that we face. I also sit on the Scrutiny Commission whose role is to hold the executive to account but in a constructive way to assist in the best decisions being made.

Local committees/Outside Bodies

As mentioned above I am a member of Narborough Parish Council where I have served for over 30 years. I have been a Blaby District Councillor for the last 8 years and am currently Leader of the Council. I also serve on the LLEP Board which is heavily involved in seeking to obtaining investment into Leicester and Leicestershire and determining how this should be spent,

3) Learning and development:

It is crucial to keep up to date with what is happening in local government and I therefore attend the regular briefings held at County Hall, read widely, attend conferences and seminars and meet with my local MP on a regular basis.
