Cabinet Friday 27th May

There was a full agenda and one of the items was the Draft Leicester, Leicestershire and Rutland Carers Strategy 2022-25. I spoke on the importance of carers and the job they do. Carers can be elderly but also much younger and that the department recognises their value and supports them by keeping them informed and guide them into getting the right support and remind carers that they have a life away from being a Carer. The department also ensures that they are kept informed of technology solutions that can support them in their caring role. Summer reading Challenge – Gadgeteers

Leicestershire libraries are calling for all children aged 4-12 years to take part in this year's Gadgeteers Summer Reading Challenge. The challenge is free to join and runs from Saturday 2nd July until Saturday 10th September in all Leicestershire Libraries including community managed libraries.

For this year's challenge, The Reading Agency has partnered with the Science Museum Group to create 'Gadgeteers', inspiring children to use their curiosity and creativity to discover the science behind the everyday, and celebrate the role of the imagination in both reading and the sciences. Children will set their own reading targets and collect rewards as they work their way through their books over the summer holidays.

Electric vehicle (EV) charging points

The webpage also includes a link to Zap-map which displays a map with locations and providers of available charge-points, the type of charge, its availability and utilisation fee (if applicable)

As you may be aware the issues arising with growing demand for Electric Vehicles and the associated infrastructure are still being understood by the authority as county are very keen to support but there are some practical issues and liabilities we are still working through. Unfortunately at this time the Highway Authority cannot currently approve or authorise trailing cables across the highway or footpaths.

Homes for Ukraine update

County have, at the time of going to print, reached 1,000 mark for the number of visa applications relating to sponsor addresses in Leicestershire. Of these over 500 have arrived in the county and 71 are in Charnwood.



Security and criminal records checks are carried out by the Government before visas are issued. The County Council is carrying out DBS and welfare/safeguarding checks on sponsors with the district councils carrying out accommodation checks on sponsor properties.

A small number of sponsors/guest arrangements have broken down.

The Children and Families Service has worked with schools to facilitate the provision of school places for children arriving from the Ukraine. School transport will be provided for Ukrainian children who need support to get to their allocated school (if not in walking distance). Please email UkraineTransport@leics.gov.uk if you are a Guest seeking help with school transport.

The County Council has established a welcome desk at EMA which is staffed every day from 8am until the last flight has arrived each evening or until 2am as needed.

Temporary Traffic Regulation Orders (TTRO)

A TTRO is required on **Springfield Road** from 26th July for 3 days. The road will be closed between Charnwood Road and The Meadows.

Access will be maintained for residents and emergency services.

The TTRO will be implemented for public safety to allow Severn Trent Water to undertake pipe works in the carriageway.

A TTRO is to be made for the following location: **Kirkhill**. The purpose is to allow Severn Trent Water to safely undertake works to replace a manhole cover and frame.



The duration is not anticipated to exceed a period of 1 day commencing Sunday 04th September.

A TTRO is to be made for the following location: **Shepshed Road, Hathern.** |The purpose is to allow Centurion Traffic Management on behalf of T-Mobile to safely undertake the installation of a Telecoms Mast and associated Cabinets.

The duration is not anticipated to exceed a period of 4 nights, 20.00 till 06.00 each night , commencing 08th August.
