<p>Countywide area-focused programme</p> <p>Annual programme in 5 areas, with 2 broad themes in each area.</p>	<p>Staggered throughout year</p> <p>An annual, one-off programme for each area, but at different times of the year for each area</p>	<p>Countywide</p> <p>County divided in 5 areas that are roughly equivalent in terms of population size</p>	<p>Fixed area budget</p> <p>£32K/yr allocated to 2 area-specific themes within each area</p>	<p>Area & theme based</p> <p>Decision Nights would bring together groups in local area working on addressing similar issues</p> <p>Supports learning and joint working within the local area & within themes.</p>
<p>Targeted area-focused programme</p> <p>Bulk of funding targeted at geographic areas of highest need, with remainder available for rest of county</p>	<p>Staggered throughout year</p> <p>An annual, one-off programme for each area, but at different times of the year for each area</p>	<p>Targeted</p> <p>Targeted on small number of areas, ie based on deprivation or prevalence of certain issues.</p>	<p>Fixed area budget</p> <p>A limited number of area-specific themes would apply</p>	<p>Area based</p> <p>Decision Nights would bring together groups trying to improve the local area.</p> <p>Supports learning and joint working within the local area.</p>
